To Computer-Based Student:

Thank you for your interest in the Virtual Education Software, inc. (VESi) online courses offered during the Spring Semester at MSU-Northern! To enroll in these courses, please complete an application form for each course making sure to specify if you would like undergraduate or graduate credits. After completion of the application form, mail or fax the form with payment to the address at the bottom of the form. An email containing the course link will be sent from VESi a few days prior to the start date of the course. Double-check to make sure that you receive the correct course link when you receive this email.

These computer-based courses must be completed during the Spring 2027 Semester at MSU-Northern. The course dates are January 19 – May 4, 2027. The last day to register for these courses is Tuesday, January 26. If this deadline is missed, you will be able to register during the Summer Semester beginning June 7. The last day to drop these courses is January 26. Your payment will be processed after this date.

You must finish your course requirements before the course end date to successfully complete the course. Grades for this class will not be posted until the end of the Spring Semester and will be available on May 19, 2027. To access your grades, go to the [MSU-Northern website](http://msun.edu) (msun.edu). Select the “Current Students” link at the top left of the page. Then scroll down and choose the “MyMSU-Northern” link and follow the directions.
